1. Apologies for Absence

3. Minutes of the previous meeting

The minutes of the Amenities and Open Spaces Committee meeting held on 13th January 2021 were duly approved.

4. Chair's Report

Members received an update from the chair on recent events/conferences attended. **Kent Plan Bee summit:** various topics were covered, including light pollution, improving bus shelters for bees, biodegradable hedge guard, soil health, pesticide usage and wild lawns.

Delivering Green Agenda: the conference focused on carbon footprint and what local councils can do to help cutting it back.

Meeting with Kent Wildlife Trust: a productive meeting with KWT discussion about opportunities, and options the parish council can take to improve biodiversity in the parish.

5. Amenities, Open Spaces and Environment Committee

The committee reviewed the proposed Terms of Reference and agreed to recommend to the full council to adopt it with a minor change to the membership section, deleting – "one whom shall be the Chair of the parish council".

6. Kent Plan Bee

A long discussion took place about the Kent Plan Bee summit, the committee agreed on the following action points:

- Investigate going pesticides free, the clerk to contact Faversham and Fulham council to find out how they achieved this.
- Contacting Ashford Borough council to find out where, when and how often they
 apply pesticides, to gain a better understanding and to see if they have any
 plans to phase the chemical out.
- Identify areas where lights could be switched off, to help insects. Residents in those areas will be consulted.
- Working out the council's carbon footprint and to draw up a 5 year plan for net zero. The plan would have to be reviewed annually. The committee recommendation is that the council should consider a professional body to help drawing up a plan.
- To make bus shelters and bins pollinator friendly by planting pollinator friendly plants
- Next parish newsletter to include tree related facts on each page in a leaf form, then ask residents to either draw or take a photo of a tree highlighting the fact they have learned from the magazine and display some photos in the parish noticeboards.
