4.6. Planning application Number 21/01315/AS

Land between the Pig and Whistle Farmhouse and Minden Cottage, Ashford Road, Great Chart, Kent Variation of condition 2 on planning permission 18/00551/AS (erection of 6 No. new dwellings with nectar-rich meadow land and reeds and swales to provide habitat for protected species, rainwater attenuation and flood relief and associated access configuration), to alter design and type of approved dwellings.

The application is only to change some semi-detached buildings to detached, and some cosmetic changes which may be an improvement on the original plan. There was a question raised on whether the new dwellings will come under the umbrella of the CMO.

There is no proposed play areas as the meadow is classed as natural play area. The group resolved to support this planning application.

5. Speed Limit Signage

A report has been put together to note the inconsistency of speed limits signs throughout the area, and also the lack signage around the new Chilmington Primary School development. There are no signs on or around Mock Lane suggesting there is a school in the area. There is a notice about a speed hump when there isn't one. The junction of Mock Lane and Chilmington Green Road is a 'death trap' as it is not well signposted and will soon become a well-used junction.

Ian Wolverson was thanked for his work on the report.

It was proposed that the parish council should contact KCC Highways to ask them what their proposals are for remedying the situation with immediate effect, which the parish council can then review. The letter should also be copied to Cllr Simkins.

7. Chilmington Green Secondary School

It was noted that a lot of the information from the developer is reliant on the second roundabout being ready to use and this may well not be the case. However, the land is in the process of being transferred over.

It was also noted that the school will not open until Chilmington Green Road has been closed off, but the roundabout will not be built until the required number of houses have been sold, and these two timelines may not match up.

There is only one entrance/exit, which is at the end of a cul-de-sac and may make emergency vehicle access impossible at drop off and pick up times.

There was also a question raised on how children from Great Chart will safely cross over to the school.

Updates can be obtained from chilmingtonsecondaryplans.co.uk and the webinar is also on there. The full planning application still hasn't been received, so comments are still welcome.

8. Planning Applications approved

Quarry View – the PC objected, and ABC refused, the applicant will be appealing, possibly using new permitted development rights allowing you to extend upwards.

It was noted that it is nice to see some refusals on applications that genuinely needed refusing.
