5. Finance

5.1. 2025-2026

The committee reviewed the budget lines for the 2025-2026 financial year and noted which lines would be carried forward, as well as those that were under or overspent. This highlighted the need to monitor spending closely in the coming year to minimise overspending. However, this may prove challenging if an emergency arises that requires additional expenditure. The Clerk will follow up on questions regarding some of the larger items of expenditure and was also reminded to be more consistent in recording items to the correct budget line.

The committee also discussed future banking arrangements, including opening additional bank accounts with better interest rates. It was agreed that the committee would consider transferring funds from the Dudley account to the Coventry Building Society, and moving funds currently held in the NatWest account to the Yorkshire Building Society. The committee also agreed to open an easy access account with a more favourable interest rate. The Clerk will look into this and report back at the full council meeting in May for information.
