8. National Planning Policy Framework Update

The update follows the draft that went out for consultation in December 2025, and the consultation that closed in March 2026.

A key test for future applications will be whether a proposal is inside or outside the built-up area. Inside the built-up area, a proposal should be approved unless the benefits of doing so would be substantially outweighed by adverse effects. Outside a built-up area, only certain kinds of development are allowed at all.
